# Property Tax Refund Program

The Village of New Lenox Board of Trustees approved refunding 75% of the Village of New Lenox's portion of the 2015 property taxes that were paid in 2016 on owner-occupied homes in which they currently reside. This amount (75%) may be adjusted if the State of Illinois reduces the share of funding to the Village of New Lenox.

Review the information inside to learn if you qualify and what you need to do to obtain your refund.

**The New Lenox Board of Trustees Voted to Refund  
Village Property Taxes  
Do you qualify?**

The Village of New Lenox Board of Trustees approved to refund 75%\* of the Village of New Lenox's portion (with 2015 tax rate of .3358) of the 2015 property taxes that were paid in 2016 on owner-occupied homes in which they currently reside. A property owner living in a single family home, a townhome, a residential condominium unit or an apartment unit within a building that he or she owns is entitled to a refund.

Owners of single family homes, townhomes and condo units will receive their refund once they prove residency in the home with a current Illinois driver's license or state identification card listing a New Lenox address. Owners of multi-unit apartment buildings must be living in one of the units to qualify for the refund. Property taxes on the entire building will be prorated to determine the amount paid by the single unit occupied by the owner.

Village residents who are eligible for the refund must complete the enclosed application. The application and copies of the following proof of residency documents must be returned to the Village of New Lenox, 1 Veterans Parkway, New Lenox, IL 60451. An envelope is provided for your convenience.

**IMPORTANT INFORMATION**

- The following proof of residency documents must be included with the enclosed **APPLICATION** for Village of New Lenox Property Tax Refund along with **COPIES OF THE FOLLOWING:**  
(1) County of Will 2015 Levy Property Tax Bill (follow the instructions on the last page of this brochure to obtain a copy from the Will County Treasurer's website); **AND**  
(2) Your current Illinois driver's license or Illinois state identification card. Please photocopy both sides of an expired Illinois driver's license.
- Original documents (i.e., tax bill) are not accepted.** Village personnel will not be allowed to make copies under any circumstances. Applicants must bring/enclose copies of all requested materials.
- The refund check will not be mailed if a past due bill, ticket or violation is owed to the Village at the time of application and/or refund or if the 2015 property taxes are not paid.
- Failure to submit complete and accurate information may result in rejection of your application.
- All completed applications are due on or before December 15, 2016.**
- Refund checks will be mailed **on or around March 6, 2017** to the listed address. This may be delayed if the state reduces our funding.
- Applicants should consult a tax professional regarding the taxability of this refund.
